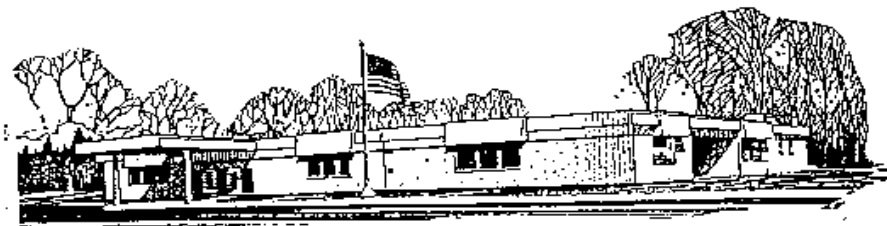

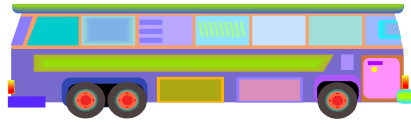

MILWAUKIE CENTER TRANSPORTATION PROGRAM FOR DAILY BUSES



The Milwaukie Center Transportation Program has the responsibility of transporting riders to and from destinations in a safe and efficient manner.



Priority programs are Senior Center focal point services: nutrition, social services, education and recreation.



Daily pickups will be on a first-come, first-served basis unless the requests are greater than our ability to serve.



Priority pickups are people living independently, and then people living in congregate settings.

WHO CAN RIDE

Any older adult or person with a disability residing in the North Clackamas Parks and Recreation District can access our transportation services.

REQUEST FOR RIDE

All ride requests are to be made through the Milwaukie Center Transportation Program **503-653-8100** between the hours of 8:30 am and 5 pm, Monday through Friday. Requests need to be made 24 hours in advance.

BEING READY

Riders need to be ready to ride ahead of scheduled pickup time. If a rider is not at the pickup location as scheduled, the driver will notify the Center and an attempt to call or find the rider will begin by using the emergency numbers listed in the Center's file.

USER FEE

Fees are required from riders to support the transportation program. Rides are \$1.50 one way or \$3 per day to the Milwaukie Center. Rides are \$2 one way to the grocery store or \$4 round trip. Riders may purchase a 5, 10 or 20 ride card. Scholarships are available for riders who need financial assistance. Please ask the Transportation Coordinator for a form.

CANCELLING A RIDE

Riders must call before 8:45 am to cancel a ride **503-653-8100**. Riders continually cancelling after 8:45 am or who are not ready for the scheduled ride, may have their service suspended.

MOBILITY DEVICES

North Clackamas Parks and Recreation District/Milwaukie Center operates three fully accessible buses which are available to safely transport the majority of non-ambulatory riders who use wheelchairs, three-wheeled scooters and other mobility devices

The mobility device must be able to fit on the lift platform and must be able to be safely secured in the bus without blocking the aisle.

Persons using three-wheeled scooters may be asked to transfer to a regular seat for safety reasons.

SHOPPING TRIPS

Shopping trips are scheduled for Tuesday and Thursday at 9:00 am, based on the rider's address. Clients must call **(503-653-8100)** 24 hours in advance to schedule the ride.

MILWAUKIE CENTER DAILY BUSSES

Door-to-door service to and from the Center for lunch, shopping and other activities. Our busses have wheelchair lift capacity. Operated by Milwaukie Center Transportation Program.

There are several types of transportation services available to older adults in North Clackamas County.

TRI-MET LIFT

Door-to-door transportation service through Tri-Met for people who are unable to ride regular busses due to disabilities.

TRI-MET MILWAUKIE SHUTTLE (Route 152)

Fixed route shuttle service between Milwaukie Transit Center and Clackamas Town Center which stops at Milwaukie Center.

TRANSPORTATION REACHING PEOPLE (T.R.P.)

Volunteers available through Clackamas County Volunteer Programs to take elderly/disabled residents for medical appointments, shopping and personal needs. Call **503-655-8208** for more information.
