North Clackamas Parks and Recreation District Appoints New Director



Clackamas County, OR – North Clackamas Parks and Recreation District (NCPRD) is pleased to announce that Scott Archer has been appointed as its new Director. Effective May 16, 2016, Archer will be responsible for the administration of all NCPRD programs and operations, reporting to the Business and Community Services Director, Gary Barth, and the Board of County Commissioners, serving as the NCPRD Board.

Archer worked for NCPRD during its formative stages (1994 – 1999), and returns to the District with over 25 continuous years of successful local government agency leadership in parks, recreation and community services. Most recently, he served as Community Services Director for the City of Oregon City, which included leading the Parks and Recreation Department. Archer held this position since 2004.

During his tenure in Oregon City, Archer managed a wide range of functions including completion of the Oregon City Parks and Recreation Master Plan, development of new neighborhood parks, and improvements to special events and programming. Additionally, he oversaw the operations of 37 parks, a 55-acre cemetery, an indoor aquatic facility, an older adult community center, heritage and historic facilities, and other city properties.

Archer is excited to be rejoining the District as Director, stating “The professional experiences and growth opportunities I received at North Clackamas Parks and Recreation District played a major role in my career path, sparking my enthusiasm and commitment to becoming a leader in the parks and recreation profession. I look forward to being a part of the dedicated staff team in serving NCPRD’s residents. The District provides excellent parks and recreation services, and I hope to help guide the further promotion and continued improvement of these outstanding quality of life opportunities for our patrons and community members.”

Highly respected in the parks and recreation industry, Archer has built valuable relationships with local partners and stakeholders throughout Oregon and Clackamas County. From 2009 to 2012, he served as a Board Member for the National Recreation and Parks Association’s Pacific Northwest region, and is recently former President of the Board of Directors for Oregon Recreation and Parks Association. Prior to his work for Oregon City, Archer served as Parks and Recreation Director for the cities of Medford, OR, and Ellensburg, WA.

Archer has a Bachelor of Science in Health and Human Performance, and Sport Science Management. He currently lives in Clackamas County with his wife of 25 years and three children, and remains active in community events, organizations and recreational activities.
