RE: NCPRD System Development Charges (SDCs) - Project List Amendments

#### **Summary**

NCPRD seeks to add three capital projects to the SDC project list so these projects will be eligible for use of SDC funding in the future, as specified in the following table:

#### Capital Projects to be added to SDC Projects List

Project							
Jennings Lodge Elementary School Neighborhood Park improvements	\$	3,400,000					
Concord Property Park and Community Center Improvements	\$	14,000,000

NCPRD last adopted a System Development Charges methodology via Ordinance 09-2007 on 10/25/2007. The methodology includes the SDC Capital Improvements Plan, which is the list of projects that are eligible for the use of SDC funds. Projects that are not on the list are not eligible for use of SDC funds. Although the Ordinance has been updated multiple times, the methodology has not been changed in those updates.

Staff began an SDC methodology update in FY 21/22, but it is on hold as decisions are clarified about District boundaries. In the absence of a new methodology and a new SDC project list, there are projects that are ready to progress to a next phase but cannot access SDC funds without being added to the list. The projects above can help serve the growth of District population. Placing these projects on the list does not obligate NCPRD to progress these projects, budget SDC funds, nor indicate that the projects are fully funded or approved for development. Cost estimates are true estimates and actual costs will vary.

After DAC consideration, the next step is for the NCPRD Board to hold a hearing as required under Oregon Revised Statue to update the existing SDC Ordinance (Ordinance 11-2017) with these additions to the 2007 project list. No other changes will be made to the ordinance, methodology or existing appendix. After the hearing and a 90-day notice period, the Board would schedule a second reading of the ordinance and consider adoption.

#### **Action Requested**

DAC to recommend that the NCPRD Board add three projects to the 2007 SDC list, including: Concord Property Park and Community Center Improvements; Jennings Lodge Elementary School Neighborhood Park Improvements; and Hull-Swanson Natural Area.

RE: Regional Transportation Plan Project List Recommendation

#### **Summary**

NCPRD staff is working with Clackamas County and other partners to add two active transportation projects to the 2023 Regional Transportation Plan (RTP), including the Clackamas River Greenway Trail and the South Mount Scott / Scouter Mountain Trail Loop / Powerline Corridor. Once a project is on the RTP it can be eligible for future federal funding.

These proposed trail corridors are within or adjacent to the District, with some portions of the trail corridors owned by NCPRD. They are important to add to the RTP list because they are on other regional and local plans and must be on the RTP list to be eligible for future funding opportunities. See the *Mt. Scott / Scouters Mtn. Trail Loop Master Plan* Map and *NCPRD Facilities Plan* Proposed Linear Park Segment L-19 through L-22 for the trail alignments.

#### Background

The RTP is the blueprint that guides investments for all forms of travel – biking and walking, driving, and transit, and the movement of goods and services throughout greater Portland. It identifies urgent and long-term needs, investments to meet those needs, and funds the region expects to have over the next 20 years.

Metro manages the RTP for the region and updates the plan every five years with input from community members and local governments. The RTP Policy Framework guides development of the project list. The RTP includes Active Transportation projects, such as regional trails like the Trolley Trail. In order to get federal

funding, transportation projects need to be in the RTP. There are three project categories: those prioritized for funding within the next seven years (by 2030), those expected to be funded by 2045, and a third list of projects that advances RTP priority goals or needs further study. 





#### **Asset Development**

The purpose of the Asset Development program is to coordinate and manage current and long-range planning, the acquisition of park land, all aspects of the District's Capital Improvement Plan (CIP), and the repair and replacement of capital assets in order to provide recreation facilities that serve District residents. (Capital repair and replace will be included in Division Report for Parks, Trails and Natural Areas).

#### **SIGNIFICANT ACCOMPLISHMENTS**

• **Strategy and Polling Work:** NCPRD finalized the contract for this work and initiated the project to research potential options for changes to governance and funding in the future.

#### **PROJECTS/TASKS BEING WORKED ON**

- **Jennings Lodge Elementary:** Work with County Procurement to negotiate the final contract for engagement, planning, and design.
- **Metro Local Share Funding**: Prepare to bring recommendation to Board of Directors to apply to Metro to request Concord park and playground elements as NCPRD's first local share project.
- **System Plan:** Work with County Procurement to finalize solicitation for a planning and engagement team for District-wide long-range "System Plan".
- Asset Inventory and Management: Run trial and evaluate software systems for streamlined geo-located asset management.
- **Trolley Trail Safety Audit:** Work with County Procurement to finalize contract with consultant for a safety audit; this work will also inform aspects of the trails planning in the upcoming system plan.
- Concord Community Park: Coordinate with project team to review 50% and 100% design development plans this winter, and plan spring meetings to review park and playground design with public.

#### **Finance**

 NCPRD received a plaque for the Government Finance Officers Association (GFOA) Distinguished Budget Presentation Award for our 2022/23 budget. This award is the highest form of recognition in governmental budgeting. Its attainment represents a significant achievement by NCPRD.





#### **CURRENT PROJECTS/TASKS**

- FY 2023/24 budget preparation.
- We are thrilled to report that we have received Budget Proposal Forms from ten District residents! As a reminder, the budget proposal form can be found on the NCPRD website at ncprd.com/financial-information.

#### **LOOKING AHEAD**

- Continued work on finalizing the FY 2023/24 budget.
- Staff will attend the OGFOA conference in Seaside, Oregon and the GFOA National conference in May, held this year in Portland.

#### **Marketing and Communications**

The purpose of the NCPRD Marketing and Communications program is to increase engagement and awareness around NCPRD's diverse spectrum of programs, activities, and projects, while ensuring clear and consistent brand messaging and design.

#### SIGNIFICANT ACCOMPLISHMENTS

- **Spring Social**: Developed materials for the Adaptive and Inclusive Spring Social event, including a flyer and digital assets, which will be used for promotion leading up to the event.
- Google AdWords Campaign: Launched a Google AdWords Campaign during the month of January to increase attendance at North Clackamas Aquatic Park. The campaign targeted keywords related to swimming pools and programs, and resulted in 6,327 impressions, 1,801 clicks through to the website, and a significant increase in attendance still being evaluated by staff.
- **Spring Programs**: Prepared for spring registration, which opens on Feb. 7, by developing promotional materials, including flyers, a mailer, signage, and digital assets. Promotion will continue until classes and programs begin.



#### PROJECTS/TASKS BEING WORKED ON

- Year in Review Print Piece: A truncated print version of the 2021-2022 Year in Review is being finalized, which will be distributed at NCPRD facilities and events.
- **Concord School Property Display Case**: Utilizing the empty display case at the Concord School Property entrance to share information on the building's history and future projects.
- Housing and Senior Services Fair: Assisting with the development of materials and promotion of the Milwaukie Community Center's Housing and Senior Services Fair, hosted by Milwaukie Community Center Foundation on March 9 from 10 a.m.-noon.
- March for Meals: Creating promotional materials and increasing awareness around the annual fundraising campaign for the Milwaukie Community Center's Meals on Wheels program. This year's campaign is organized by the Milwaukie Community Center Foundation. More information at ncprd.com/march-for-meals.

#### **LOOKING AHEAD**

- **Awareness campaign**: NCPRD will be developing concepts for an awareness campaign, designed to increase engagement across all departments.
- **Trolley Trail Brochure:** The Trolley Trail brochure will be getting a refresh, with additional copies printed for distribution.

#### **Older Adult Services**

The purpose of the Older Adult Services program is to provide coordinated nutritional, transportation, educational and social service programming to the community's older adults and persons with disabilities; assisting them in remaining independent and helping them thrive in their later years.

#### SIGNIFICANT ACCOMPLISHMENTS

- The Nutrition Program's Meals on Wheels deliveries continue to reach all-time highs in clients served and daily meals provided. We are averaging over 270 meals delivered daily. Each new start for this program begins with a phone referral and then followed up with an in-person athome assessment by one of our Center's social workers. This visit establishes eligibility for the program and allows staff to discuss with the client if there are other services they may need to remain independent in their home.
- The Milwaukie Community Center's Advisory Board held a special goal setting meeting this
  month. This board, which has been instrumental in making the Milwaukie Community Center
  more welcoming to community members of all ages, is looking to further increase outreach
  and participation.

#### PROJECTS/TASKS BEING WORKED ON

• Appointments for AARP free tax preparation begin on February 6. This is a great partnership between AARP and the Milwaukie Community Center. This year, volunteer tax preparers



expect to complete over 650 returns for low income and senior citizens. Any donations received will benefit the MCC Foundation.

#### **LOOKING AHEAD**

Preparations have begun for this year's March for Meals (M4M's). This is the Nutrition
Program's most important fundraiser with a goal of \$25,000. The MCC Foundation is looking for
partnerships with area businesses to be collection sites for citizens to contribute to this
campaign. The Center's sponsor, Bob's Red Mill, is matching the first \$10,000 donated to this
campaign.

#### **Parks, Trails and Natural Areas**

The purpose of the Parks, Trails and Natural Areas program is to provide management, maintenance and ongoing stewardship services to NCPRD residents and visitors so they can access safe, clean and well maintained parks, trails and natural areas both now and into the future.

#### SIGNIFICANT ACCOMPLISHMENTS

- Hired Avery Mudra in the FTE Building Maintenance Assistant position.
- Milwaukie Community Center generator has been repaired and is functioning. The generator was
  used recently for a power outage and this allowed Meals on Wheels and Milwaukie Community
  Center staff to continue working.
- NCPRD planted over 500 plants and trees as part of the 22/23 Capital Repair Replace projects at the Aquatic Park, Harmony Road Neighborhood Park, Wichita Park, Boardman Wetland Nature Park, and Stringfield Family Park.



#### PROJECTS/TASKS BEING WORKED ON

NCPRD has begun work on pollinator gardens at Hawthorne Park and Stringfield Family Park.
 Natural Areas team is continuing fall work focused on trail work, tree work, and controlling specific weeds where success is best in the fall-early winter.



- Damaged picnic tables have been picked up and will be returned to the parks as they are repaired.
- Working on completing conditional use ZDO required updates.

#### **LOOKING AHEAD**

- Recruiting for a Park Maintenance Specialist position due to a resignation.
- Park planting work has begun and will continue through March.

#### Recreation

The purpose of the NCPRD Recreation program is to provide a variety of recreational and educational opportunities directly and in partnership with other providers to enhance personal health and the quality of life for all residents of the District.

#### **SIGNIFICANT ACCOMPLISHMENTS**

• We held our first Lunar New Year Celebration on January 22 with performances of guzheng (Chinese instrument), dancers, drummers, dragon, Chinese yoyo demonstration and lion dancers. Activities during the event included making lanterns, bracelets and fans, searching fortunes through fortune sticks, playing games, learning Chinese characters and getting temporary tattoos. Guests were able to sample pineapple cakes, rice crackers and other Asian snacks and received a hong bao (red envelope) with a lucky chocolate coin inside. Over 750 people attended the celebration.





- Free workshops were held for Strength and Relaxation Yoga, Tai Chi Beginning 1, Tai Chi For Better Health, and Foxtrot before winter term.
- A preschool sing-a-long began this month at the MCC. Preschoolers, ages 1-5, participated in a sing-a-long to familiar songs with a live ukulele group, and then enjoyed milk and cookies.
- Tai Chi For Better Health and Tai Chi Beginning 1 began this month at Concord School Property.
- Hoopers hit the court! The 160 teams (1,580 players) began their season on January 9 at ten North Clackamas School District gymnasiums and our two facilities (Concord and Clackamas School Properties). Judging by all of the smiles, it appears that it is going to be another fun and memorable season of basketball.







- Shooting Stars Big Dippers (ages 12-25) began practicing on January 9 and the Little Dippers
  (ages 5-14) began their basketball season on January 21. The Shooting Stars program is for
  players with additional needs and cognitive disabilities.
- Trail Blazer's NCPRD Night on January 10 was a huge success with Hoopers families purchasing 500 tickets. By purchasing a ticket, players were allowed to watch the Blazer players warm-up 30 minutes before the doors opened and shoot a free throw on the Moda Center Court. NCPRD received \$5 for every ticket sold which raised \$1,500 for our program scholarship fund.
- Cheer Starz Dance and Cheer program is off to a great start. The three teams are having fun learning the fundamentals of dance and cheer in preparation for their first performance on February 18.
- Pre-Kindergarten basketball is underway with a full class of 15 athletes, ages 3-5. Players are
  having a great time developing their basketball skills alongside their parents under the
  direction of NCPRD staff.
- Open Gym Volleyball for adults began on January 8 at the Concord School Property gymnasium. The winter session began on January 8 and runs through March 26. Staff reported that the 16 participants had a great time and wanted more.



• Clackamas County Special Olympics began their practices in the Concord School Property gymnasium on Saturday, January 7 and continue through March 11.







- By utilizing newly trained staff, Aquatic Park staff successfully added nine swim lesson classes for a total of 48 additional participants from the waitlists for the first winter session.
- The Aquatic Park is now offering Parent Preschool swims for families to attend every day of the week. The weekend attendance has been steadily increasing with an average of 100 participants, with a high of 140 participants on a Sunday.
- The Aquatic Park has hired 13 lifeguards, two cashiers and two aerobics instructors. We are excited to grow our team.
- The Aquatic Park hosted six local high school swim meets during the month of January.









#### **PROJECTS/TASKS BEING WORKED ON**

- Spring registration begins at 9 a.m. on February 7 for NPCRD residents and February 14 for non-residents.
- Staff is working on summer programming and events including summer camps, Movies in the Park, Recmobile and Concerts.
- Staff are finalizing April 15 May Day Lei Day and April 22 Earth Day: Kids Container Gardening events.
- Sunday Pickleball in the Concord School Property gymnasium is being developed.



- Planning has begun for an Adaptive and Inclusive Spring Prom scheduled for May 20. This is sure to be a very special night for our adaptive and inclusive community, ages 15 and older.
- Staff is busy putting together the schedule for NCPRD's spring adult softball season.
- Preparations are underway for the March 2023 opening of the North Clackamas Park baseball/softball fields.
- Boo! Planning for NCPRD's Octobers Boo Bash/Haunted Concord has begun.
- An ELearning curriculum for staff to complete annual trainings has been implemented. This
  allows us to assign staff to complete the training on their own schedule rather than trying to
  coordinate large staff meetings.
- Staff is developing dates for our spring swim instructor academy and lifeguard training offerings.

#### **LOOKING AHEAD**

- Staff is exploring the development of two new programs; Water Safety, Fitness and Fun program for families and a swim for those with sensory adaptations.
- Exploring weekday sports programming ideas for youth and adults.
- Begin working on NCPRD's summer and fall adult softball league schedules.


